CLASS REQUIREMENTS AND PRICING: (All class levels run September - June)

There will be a \$25 registration fee for all new students.

PRE-BALLET: One payment of \$550 per year due August 14

LEVEL 1A: One payment of \$600 per year due August 14

LEVEL 1B: One payment of \$1,500 per year due August 14; or two payments of \$750 due August 14 and October 27

LEVEL 2: One payment of \$2,500 per year due August 14; or two payments of \$1,250 due August 14 and October 27

LEVEL 3: One payment of \$3,250 per year due August 14; or two payments of \$1,625 due August 14 and October 27; or four quarterly payments of \$812.50 due August 14, October 27, January 26, 2024 and March 29, 2024

LEVEL 4: One payment of \$4,000 per year due August 14; or two payments of \$2,000 due August 14 and October 27; or four quarterly payments of \$1,000 due August 14, October 27, January 26, 2024 and March 29, 2024

LEVEL 5: One payment of \$4,250 per year due August 14; or two payments of \$2,125 due August 14 and October 27; or four quarterly payments of \$1,062.50 due August 14, October 27 January 26, 2024 and March 29, 2024
