**Professional Training Program: (1)** payment of \$4400 per year due Aug 16 **or (2)** payments of \$2200 due Aug 16 and Oct 25 **or (4)** quarterly payments of \$1100 due Aug 16, Oct 25, Jan 24, Mar 28

**Tuition Agreement:** The operation of New York State Ballet Training Academy (NYSBTA) is tuition based; therefore for the school to operate smoothly, families must honor their financial obligations. The following policies are in effect for tuition and fees:

• All families are responsible for meeting their tuition obligation to New York State Ballet Training Academy on a timely basis.

A charge of \$20 will be assessed if payment is late and your child may be asked not to participate in class until the account is made current.

• No tuition payments will be refunded and it is the student's responsibility to make up any classes missed.

• A \$25 returned check fee will be assessed for any check returned to NYSBTA as non-payable.

**Attendance:** Please notify the Artistic Director via text, phone, or email if you will be absent or late for class. Any missed classes can be made up within the same month that the class was missed.
